



# TOWN OF SHELBURNE

## Repeal By-Law

BEING ENACTED by the Town Council of the Town of Shelburne, under the authority of the Municipal Government Act:

1. This By-Law shall be known as the "Repeal By-Law"
2. Any violation of any By-Law of the Town arising before the date of approval of repeal or amendment of these By-Laws shall be enforced by the Town as if this By-Law had not been amended or repealed by the Minister of Municipal Affairs and any assessment, rate, charge, tax, fee, liability, fine, or penalty outstanding under any existing By-Law of the Town of Shelburne may be collected by the Town as if this By-Law had not been approved by the Minister of Municipal Affairs.
3. The following By-Laws are hereby repealed:
  - a) The Committee and Boards By-Law

  - d) Municipal Land Transfer Tax By-Law  
The Municipal Land Transfer Tax By-Law, passed by Council on the 3<sup>rd</sup> day of May, 1989, signed and sealed by the Town Clerk on the 20<sup>th</sup> day of June, 1989;

The Lord's Day By-Law, passed by Council on the 7<sup>th</sup> day of May, 1980, signed and sealed by the Town Clerk on the 23<sup>rd</sup> day of May, 1980;
